AN OVERVIEW OF IPHA PRIORITIES FOR 2020

SUPPORTING PUBLIC HEALTH FUNDING

State funding supports the critical work of local public health agencies - our front line of prevention. The state's portion of public health funding is only 21%, the rest comes from federal and other funds, like grants. Federal funding for public health is on the decline, yet the need remains at the local level. A stable state funding model that prioritizes local public health is necessary to modernize and support lowa's public health infrastructure.

This is a priority because...

- In 2018, the State's allocation for public health was only \$15.68 per person.
- 70% of adults have unhealthy weight; 26,000 youth use tobacco products; violence killed 571 people in 2017. Racial and ethnic minorities carry the disproportionate burden of illness and disease.
- Local public health agencies are best equipped to determine and manage the health risks most affecting their communities.

PROMOTING HEALTH IN ALL POLICIES

The health of lowans contributes to a robust economy and the livability of our state. By looking at the health equity impact of decision-making, we will increase efficiency and cost-effectiveness in our efforts to improve the health of lowans. We must make wise policy and financial investments in all sectors for lowa to truly become the "healthiest state in the nation"

This is a priority because...

- Our greatest health challenges and solutions are highly complex and extend beyond the doctor's office.
- The social, physical, and economic environments in which lowans live, work, learn and play significantly impact their health.
- Improving the health of lowans requires collaboration with experts in housing, transportation, education, water and air quality, criminal justice, and employment..

PROTECTING IOWA'S IMMUNIZATION RATES

Vaccine requirements ensure the population is protected from disease. Achieving and maintaining high vaccination rates across the life span are two of the most important safeguards to prevent the spread of vaccine-preventable diseases, including infections, cancers, and other chronic diseases.

This is a priority because...

- Vaccine hesitancy is recognized as one of the Top 10 threats to global public health in 2019.
- For every \$1 spent on vaccines, \$10.10 is saved.
- Vaccination protects the individual and prevents the spread of disease in Iowa's communities...
